
A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to program planning,
4 analysis, budgeting (BUF 102) the following sums, or so much
5 thereof as may be necessary, to fund for fiscal
6 biennium 2015-2017 all collective bargaining cost items in the
7 agreement negotiated with the exclusive bargaining
8 representative of collective bargaining unit (8):

 6 adjustments authorized by chapter 89C, Hawaii Revised Statutes,
 7 for state officers and employees who are excluded from
 8 collective bargaining and belong to the same compensation plans
 9 as those officers and employees within collective bargaining
 10 unit (8):

4 shall be paid wholly or proportionately, as the case may be,
5 from the respective funds.

6 SECTION 6. Funds appropriated or authorized by this Act
7 that are not expended or encumbered by June 30, 2016, and
8 June 30, 2017, of the respective fiscal years, shall lapse as of
9 those dates.

10 SECTION 7. This Act, upon its approval, shall take effect
11 on January 7, 2059.
