A BILL FOR AN ACT

RELATING TO ALOHA TOWER DEVELOPMENT CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 206J-4, Hawaii Revised Statutes, is
2 amended by amending subsection (b) to read as follows:
3 "(b) The development corporation shall consist of a board
4 of directors having [~~three~~] six voting members: The director of
5 business, economic development and tourism[, ~~the director of~~
6 ~~transportation, and~~] or the director's designee, the chairperson
7 of the board of land and natural resources or the chairperson's
8 designee, the deputy director of transportation, harbors
9 division, one member representing the maritime industry to be
10 appointed by the governor as provided in section 26-34, one
11 member to be appointed by the speaker of the house, and one
12 member to be appointed by the president of the senate. The
13 board, by a majority vote, shall elect a chairperson from within
14 its membership."

15 SECTION 2. Section 206J-4, Hawaii Revised Statutes, is
16 amended by amending subsection (d) to read as follows:

1 "(d) The board [~~shall~~] may appoint a chief executive
2 officer. [~~The~~] If a chief executive officer is appointed, the
3 board shall set the salary of the executive officer, who shall
4 serve at the pleasure of the board and shall be exempt from
5 chapter 76."


6 SECTION 3. Statutory material to be repealed is bracketed
7 and stricken. New statutory material is underscored.

8 SECTION 6. This Act, upon its approval, shall take effect
9 on July 1, 2015.
