A BILL FOR AN ACT

RELATING TO ELECTRIC VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 421I, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 **"§421I- Electric vehicle charging system installation**
5 **requests; board of directors approval or denial.** (a) Within
6 sixty days of receipt of a shareholder's complete request for
7 approval to install an electric vehicle charging system, the
8 board of directors shall make a decision to approve or deny the
9 shareholder's request. The shareholder's request shall not
10 deemed complete unless information on the cost and impact of the
11 installation is included with the request. The installation of
12 the electric vehicle charging system shall be subject to section
13 196-7.5.

14 (b) For the purposes of this section, "electrical vehicle
15 charging system" shall have the same meaning as in section
16 196-7.5."



1 SECTION 2. Chapter 421J, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 **"§421J- Electric vehicle charging system installation**
5 **requests; board approval or denial.** (a) Within sixty days of
6 receipt of a member's complete request for approval to install
7 an electric vehicle charging system, the board shall make a
8 decision to approve or deny the member's request. The member's
9 request shall not deemed complete unless information on the cost
10 and impact of the installation is included with the request.
11 The installation of the electric vehicle charging system shall
12 be subject to section 196-7.5.

13 (b) For the purposes of this section, "electrical vehicle
14 charging system" shall have the same meaning as in section
15 196-7.5."

16 SECTION 3. Chapter 514A, Hawaii Revised Statutes, is
17 amended by adding a new section to part V to be appropriately
18 designated and to read as follows:

19 **"§514A- Electric vehicle charging system installation**
20 **requests; board approval or denial.** (a) Within sixty days of
21 receipt of an apartment owner's complete request for approval to



1 install an electric vehicle charging system, the board of
2 directors shall make a decision to approve or deny the apartment
3 owner's request. The apartment owner's request shall not deemed
4 complete unless information on the cost and impact of the
5 installation is included with the request. The installation of
6 the electric vehicle charging system shall be subject to section
7 196-7.5.

8 (b) For the purposes of this section, "electrical vehicle
9 charging system" shall have the same meaning as in section
10 196-7.5."

11 SECTION 4. Chapter 514B, Hawaii Revised Statutes, is
12 amended by adding a new section to part VI to be appropriately
13 designated and to read as follows:

14 **"§514B- Electric vehicle charging system installation**
15 **requests; board approval or denial.** (a) Within sixty days of
16 receipt of a unit owner's complete request for approval to
17 install an electric vehicle charging system, the board shall
18 make a decision to approve or deny the unit owner's request.
19 The unit owner's request shall not deemed complete unless
20 information on the cost and impact of the installation is

1 included with the request. The installation of the electric
2 vehicle charging system shall be subject to section 196-7.5.

3 (b) For the purposes of this section, "electrical vehicle
4 charging system" shall have the same meaning as in section
5 196-7.5."

6 SECTION 5. New statutory material is underscored.

7 SECTION 6. This Act shall take effect upon its approval.
