A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. (a) The state historic preservation division
3	of the department of land and natural resources shall conduct a
4	survey to identify potential historic districts and single-
5	family residences that may be eligible for listing on the Hawaii
6	register of historic places.
7	(b) The state historic preservation division of the
8	department of land and natural resources shall submit a report
9	to the legislature no later than twenty days prior to the
10	convening of the regular session of 2018. The report shall
11	include the results of the division's compliance with subsection
12	(a), including the number and types of properties examined and
13	identified as potentially eligible to be included on the Hawaii
14	register of historic places.
15	SECTION 2. There is appropriated out of the general
16	revenues of the State of Hawaii the sum of \$100,000 or so much
17	thereof as may be necessary for fiscal year 2015-2016 and the
18	same sum or so much thereof as may be necessary for fiscal year

7	SECTION 6. This Act shall take effect on July 1, 2015.
