Sir:

Your Committee on Judiciary and Labor, to which was referred
S.B. No. 2163, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO SERVICE OF PROCESS,"

begs leave to report as follows:

The purpose and intent of this measure is to allow the
Director of Health to give notice of water pollution and solid
waste pollution violations via a posting on a searchable
government website when attempts to serve written notice in person
and by mail have been unsuccessful.

Your Committee received testimony in support of this measure
from the Office of Hawaiian Affairs; Department of Planning and
Permitting, City and County of Honolulu; Conservation Council for
Hawai'i; Sierra Club of Hawai'i; and one individual. Your
Committee received comments on this measure from the Department of
Health.

Your Committee finds that personal service of notices of
violation are not always successful and publication of notices in
daily newspapers can be costly. By authorizing public notices to
be posted on a searchable government website, this measure allows
for such notices to be available to the public for an
indeterminate time and without cost.

Your Committee has amended this measure by:



- (1) Authorizing the Director of Health to provide notice by conspicuously posting a sign on the property, if appropriate; and
- (2) Inserting an effective date of January 7, 2059, to encourage further discussion.

As affirmed by the record of votes of the members of your Committee on Judiciary and Labor that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 2163, S.D. 1, as amended herein, and recommends that it pass Third Reading in the form attached hereto as S.B. No. 2163, S.D. 2.


