

I. Background and Summary

1. A brief description of the applicant's background;

The Hawai'i LGBT Legacy Foundation is a 501c(3) not-for-profit organization serving the lesbian, gay, bisexual and transgender (LGBT) community throughout the State of Hawai'i. Founded by prominent members of that community in 2008, the Foundation seeks to:

- Nurture, support, unite and empower the LGBT community as an integral part of the larger whole
 of Hawai'i society, by creating a healthier, tolerant and compassionate environment for all;
- Encourage a thriving and sustainable entrepreneurial climate within the LGBT business and professional communities which welcomes, respects and serves all;
- Facilitate the provision of public, professional and not-for-profit services to members of the LGBT community, particularly to those who are in need;
- Serve as a bridge and conduit for communication, understanding and trust-building between LGBT residents and members of the greater community at large;
- Enlighten and educate the general public about the many issues affecting LGBT residents, so that our state's diversity might truly define us as a society rather than simply divide us by category; and
- Foster a proactive and inclusive spirit of ho'oponopono (reconciliation), 'ohana (family), kōkua (cooperation) and maika'i (good will) amongst everyone, gay and straight alike, especially on matters and issues of mutual concern.

As the LGBT community emerged from society's shadows over the last 40-plus years to assert itself as an equal participant and partner in the American dream, the Hawaii LGBT Legacy Foundation was born of necessity, with the realization that until such time as the concept full equality was finally established and embraced by all citizens, our LGBT community in these islands would likely need to take care of our own.

To address those needs and fulfill the Foundation's guiding principles, it was determined through much effort and consensus building that we adopt the following four goals:

- 1) Open a community center for gay and lesbian Hawai'i residents:
- Create a secure and protective environment for gay, lesbian, bisexual, transgender and questioning youth;
- 3) Enlighten and educate public officials and citizens about the LGBT community and its often unique issues; and

4) Plan and provide for the growing needs of an aging LGBT baby-boomer population.

From that humble and challenging beginning, the Hawai'i LGBT Legacy Foundation has since come to establish itself as a bedrock organization within the local LGBT community, committed to assisting all LGBT residents and organizations actualize their full potential and realize their goals and dreams.

LGBT community centers have become the primary local agents of change in the national movement working toward the equality and empowerment of LGBT people nationwide. The LGBT Center – Waikiki, which opened in 2013, not only functions as a meeting, educational and training center for members of the LGBT community and their friends, but is also the home base for 14 different not-for-profit organizations that serve the LGBT residents throughout the islands. Its presence has significantly advanced Hawai'i's ranking as "gay-friendly" place to visit and do business, leading to a marked increase in LGBT visitors to our islands and a corresponding increase in LGBT-derived tax revenues to the state.

The year 2015 also saw the Honolulu and Hawai'i Island Pride Parades and Festivals come under the umbrella of the Hawai'i LGBT Legacy Foundation, which through the support of 15 corporate sponsors were expanded to include LGBT youth educational programming. The 2015 parade in Honolulu was seen by over 20,000 spectators, and for the first time included a U.S. Navy Color Guard from Pearl Harbor and the U.S. Army Marching Band from Fort Shafter.

2. The goals and objectives related to the request;

Now that has secured a permanent site for the LGBT Center has been secured and several educational initiatives which target issues facing the community are being developed, the Hawai'i LGBT Legacy Foundation must address the issue of permanent staffing. While the Foundation acknowledges the important role of nonprofit board members, volunteers, public officials, academics, and writers/ bloggers in the larger LGBT movement, the present demands on the Foundation and the LGBT Center – Waikiki now require the recruitment and retention of full-time executive director and support staff.

It is imperative that the Hawai'i LGBT community develop and nurture leadership talent who can develop the programs and deliver the services to members of our community. And because these people often devote their working lives to advancing LGBT equality, they should also benefit from the same level of investment in their skills, knowledge and career development as those working in for-profit business or government, where such investments are more common.

In the course of their strategic planning activities, many not-for-profit organizations – not just those in the LGBT community – neglect to identify and secure critical and necessary investment in their own human resources. In fact, more often than not, many not-for-profit strategic plans do not include the plans and means to systematically develop, recruit and retain what is arguably an organization's most important asset, which is the leaders and teams who do the actual work.

3. The public purpose and need to be served;

Strong LGBT organizations such as the Hawai'i LGBT Legacy Foundation remain the backbone of the movement for equality. Talented leaders have played an essential role in advancing the equality of LGBT

Americans and indeed, they are central to the movement's ongoing work to protect those rights which have already been secured. But the movement cannot succeed based on the work and initiative of such enterprising individuals alone. Further, key leaders and volunteers at the Foundation are cognizant of the fact that as many of us are members of a now-aging "Baby Boom" generation, the organization must begin to prepare for a transition in leadership which will require us to eventually pass the torch to a new generation of activists and champions.

4. Describe the target population to be served; and

The Hawai'i LGBT Legacy Foundation serves the lesbian, gay, bisexual and transgender (LGBT) community throughout the State of Hawai'i, which is estimated to be about 56,000 individuals. Further, the Foundation can effectively serve as the liaison for the State and its counties with that community.

5. Describe the geographic coverage.

Given that the bulk of the State's LGBT population resides on the island of O'ahu, much of the Foundation's activities are focused on events in the City and County of Honolulu. However, the Foundation does maintain an active presence on the neighbor islands,

II. Service Summary and Outcomes

The Hawai'i LGBT Legacy Foundation's board members believe that there is huge potential for the LGBT not-for-profits presently under the Foundation's umbrella to collaborate and thus create shared resources that contain and reduce overall costs and improve effectiveness in the fulfillment of an organization's mission. But at present and with an all-volunteer staff whose members often have other paying jobs, it is vital that the Foundation recruit and retain an executive director with the skills and track record necessary to take the LGBT Center – Waikiki and its affiliates to the next level.

The Executive Director will be responsible for working with the Board to meet the organization's strategic goals, assist the Board in laying a strong foundation for the organization's fiscal stability, provide direction to the organization's paid and volunteer staff and consultants, identify funding opportunities, and serve when called upon as the organization's public spokesperson.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service.

Subject to the availability of funding, the Hawaii LGBT Legacy Foundation will begin solicitation of applications for the position of executive director in August 2017, and will select a candidate by October 1, 2018.

3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results.

The Hawai'i LGBT Legacy Foundation Board of Directors possesses an in-house capacity to assess organizational demographics such as quality control, client satisfaction, rates of participation, and age and ethnicity, and provide the rigorous analysis necessary to ascertain current and prospective need and provide definitive direction.

4. List the measure(s) of effectiveness that will be reported to the State agency through which grant funds are appropriated (the expending agency). The measure(s) will provide a standard and objective way for the State to assess the program's achievement or accomplishment. Please note that if the level of appropriation differs from the amount included in this application that the measure(s) of effectiveness will need to be updated and transmitted to the expending agency.

The Foundation will report directly to the expending agency upon hiring an executive director, and will further update the agency on its fundraising efforts to ensure that its efforts are sustainable. It is not our intention to rely on government subsidies for operations. Rather, the Foundation's capacity will be increased and sustained to the extent that it can serve as an effective public advocate for and liaison to the Hawaii LGBT community, which comprises about 5% of the state's population, and plan for that community's needs as members of the "Baby Boom" generation age and retire.

It should be noted that other states and cities have specific government agencies which address LGBT issues, while Hawaii does not. The Hawaii LGBT Legacy Foundation can serve in that capacity as the State's conduit to and from the community, which can be particularly beneficial during those times when there are matters which may require the LGBT community's concern and cooperation.

The Hawai'i LGBT Legacy Foundation will seek funding for organizational capacity building from the Evelyn and Walter Haas, Jr. Fund; CenterLink: The Community of LGBT Centers; the Horizons Foundation; the Arcus Foundation; the Calamus Foundation; and the Wallace Alexander Gerbode Foundation.

Further, the Hawai'i LGBT Legacy Foundation will eventually develop and institute a planned giving and endowment program to provide for the continued sustainability of its operations and programs, create a long-term financial base to ensure fiscal stability, and mitigate any inordinate reliance upon government support or annual fundraising drives. Fund development will become an integral part of the Legacy Foundation's organizational routine, so that current funds can be effectively administered while new monies are continuously raised.

4. The applicant shall provide a listing of all state and federal tax credits it has been granted within the prior three years. Additionally, the applicant shall provide a listing of all state and federal tax credits they have applied for or anticipate applying for pertaining to any capital project, if applicable.

As a 501c(3) not-for-profit and tax-exempt organization, the Hawai'i LGBT Legacy Foundation neither applies for or receives tax credits.

5. The applicant shall provide the balance of its unrestricted current assets as of December 31, 2016.

The Hawai'i LGBT Legacy Foundation's current balance of assets is \$46,643.88.

At present, the Hawai'i LGBT Legacy Foundation does not have any government grants or contracts. It has, however, recently applied for a \$15,000 grant from the City and County of Honolulu for the 2017 Pride Festival.

David Brustein, Esq., is a local attorney who presently serves as board chairman of the Hawaii LGBT Legacy Foundation. He has served on the boards of several non-profits, and was a member of the Governor's Committee on AIDS. He is one of the founding members of the Life Foundation of Hawaii's legal clinic, and has litigated important civil rights cases before the Hawaii State Supreme Court.

Jacce Mikulanec serves as the Foundation's vice-chairman, and has extensive experience as staff member for the Honolulu City Council, Hawaii State Legislature and then-Lt. Gov. Brian Schatz. He presently works for the Hawaii Medical Services Association in the field of policy and government relations.

Robert J. Kauffman serves as the Foundation's Treasurer, and is a former FBI special agent (retired in 2010), and currently works as an independent consultant specializing in government security and compliance matters.

David McEwan, M.D., is a retired physician and co-founder of the Hawaii LGBT Legacy Foundation, for which he is also past board chairman. He has served the public in various capacities on numerous city and state committees in areas of public health. He presently serves on the board of Hawaii Public Television.

B. Facilities

The Hawai'i LGBT Legacy Foundation runs the Honolulu LGBT Community Center, which is located at the Waikiki Community Center at 310 Paoakalani Ave., Suite 206E, Honolulu HI 96815. The facility is available free of charge to all approved LGBT non-profits, groups and individuals for meetings and social networking. It is presently staffed by volunteers.

V. Personnel: Project Organization and Staffing

A. Proposed Staffing, Staff Qualifications, Supervision and Training: The applicant shall describe the proposed staffing pattern and proposed service capacity appropriate for the viability of the request. Core responsibilities of the Executive Director are:

- Assist the Board's efforts in fundraising and resource development, to ensure that the Legacy Foundation has the financial and human resources necessary to implement its strategic plan and operational goals;
- **Finance,** which includes budget development, ensuring proper fiscal accounting and controls, and ensuring all requisite legal and fiduciary compliance;
- Administration and management of all organizational and human resource functions, which include the hiring, development, motivation and retention of staff, and oversight and development of the organizational infrastructure necessary to support and sustain growth, and developing job descriptions for both paid and volunteer staff:
- Communications, which include serving as spokesperson for the Foundation and LGBT Center –
 Waikiki, and representing both before the public, prospective and current grantors and funders, the
 progressive community, the media, and other constituents and allies;
- Community relations, which include the building and strengthening of networks and coalitions
 with other community and social justice organizations, and promoting public presence and
 organizational identity as a leader in the Hawai'i LGBT and social justice movements;
- Member Cultivation, which include the maintenance and support of Foundation member organizations through the development and execution of trainings relevant to their needs and interests, and providing technical assistance and support for center members and clientele;
- Initiative, which includes recognizing and bringing to the Board's attention any potential issues that may affect the Legacy Foundation and LGBT Center, and implementing plans to reach organizational goals as determined by the Foundation's Board of Directors; and
- Dependability, which include seeking increasing responsibility while remaining conscientious, thorough, accurate, and reliable with respect to achieving the organization's goals, and availability and responsiveness to various issues and concerns affecting the LGBT community in Hawai'i, as they may arise,

Preference will be given to candidates who possess the following attributes:

- At least a bachelor's degree from an accredited institution of higher learning.
- At least five years of executive leadership experience, preferably with an LGBT community center, social justice organization or national association;
- Exceptional written and verbal communications skills;

- Training, coaching or mentoring experience;
- A deep understanding of board governance, organizational development and not-for-profit best practices;
- Prior experience in the management of budgets, asset and liability balance sheets, and not-forprofit organizational finance;
- A good understanding of government / foundation grant processes and contracts;
- A track record of success cultivating, stewarding and soliciting corporate, foundation and individual qifts;
- Strong relationship building skills, including a track record of success in fostering collaboration and strengthening networks;
- An approachable, collaborative and transparent leadership style, including experience working with and at the direction of a not-for-profit board of directors / trustees;
- Knowledge of marketing and communications strategies used to build brand awareness, increase organizational visibility and deliver effective messaging; and
- A working knowledge of the history and public policy issues facing LGBT and HIV-affected communities;
- A working knowledge of and empathy for gender identity / expression issues;
- An understanding of racial and economic justice issues and their impact on LGBT and HIVaffected communities;
- Belief in the societal benefits of diversity and inclusion, and a commitment to social justice; and


The undersigned authorized representative of the applicant certifies the following:


