The purpose and intent of this measure is to increase notary
public fees.

Your Committee received testimony in support of this measure
from the Association of Hawaii Notaries.


Your Committee finds that notary public fees have not been
amended since 1995. Accordingly, this measure increases the fees
notaries public are entitled to demand and receive.

Your Committee has amended this measure by clarifying that
the notary public fee for administration of oath also applies to
affixing the certificate of oath to that document and includes up
to one duplicate original.

As affirmed by the record of votes of the members of your
Committee on Commerce, Consumer Protection, and Health that is
attached to this report, your Committee is in accord with the
intent and purpose of S.B. No. 333, as amended herein, and
recommends that it pass Second Reading in the form attached hereto
as S.B. No. 333, S.D. 1, and be referred to your Committee on Ways
and Means.


