# A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 **PART I**

2 SECTION 1. There are appropriated from the source of  
3 funding indicated below to health premium payments (BUF 761) the  
4 following sums or so much thereof as may be necessary to fund  
5 for fiscal biennium 2017-2019 the Hawaii employer-union health  
6 benefits trust fund costs in the agreement negotiated with the  
7 exclusive bargaining representative of collective bargaining  
8 unit (14):

10 SECTION 2. Funds appropriated by this part shall be  
11 allotted by the director of finance to the appropriate state  
12 departments for expenditure in the respective fiscal year for  
13 the purposes of this part.

15 **PART II**

16 SECTION 3. There are appropriated from the source of  
17 funding indicated below to health premium payments (BUF 761) the  
18 following sums or so much thereof as may be necessary to fund



1 for fiscal biennium 2017-2019 the Hawaii employer-union health  
2 benefits trust fund costs authorized by chapter 89C, Hawaii  
3 Revised Statutes, for state officers and employees who are  
4 excluded from collective bargaining unit (14):

7 SECTION 4. Funds appropriated by this part shall be  
8 allotted by the director of finance to the appropriate state  
9 departments for expenditure in the respective fiscal year for  
10 the purposes of this part.

11 **PART III**

12 SECTION 5. Salary increases and cost adjustments provided  
13 in this Act for any officer or employee whose compensation is  
14 paid, in whole or in part, from federal, special, or other funds  
15 shall be paid wholly or proportionately, as the case may be,  
16 from the respective funds.

17 SECTION 6. Funds appropriated or authorized by this Act  
18 that are not expended or encumbered by June 30, 2018, and  
19 June 30, 2019, of the respective fiscal years, shall lapse as of  
20 those dates.

21 SECTION 7. This Act shall take effect on July 1, 2017.
