RELATING TO EMPLOYMENT.

LAB, JUD, FIN

Requires certain employers in the retail, hospitality, and food services to provide employees with advance notice of work schedules.

Authorizes an employer to create voluntary standby lists. Requires overtime pay for employees who work during certain rest periods between work shifts. Requires overtime pay if employer gives no

advance notice of work schedule.

HB 2018

RELATING TO EMPLOYMENT PRACTICES.

LAB, JUD

Status Adds reproductive health decisions to the list of categories that are

protected against discriminatory employment practices.

<u>HB 1627</u>

RELATING TO THE MINIMUM WAGE.

LAB, FIN

<u>Status</u> Repeals exemption authorizing compensation of impaired individuals

at less than minimum wage.

<u>HB 2137</u>

RELATING TO EQUAL PAY.

LAB, JUD

Status Prohibits prospective employers from requesting or considering a job

applicant's wage or salary history as part of an employment application process or compensation offer. Prohibits enforced wage secrecy and retaliation or discrimination against employees who disclose, discuss,

or inquire about their own or coworkers' wages.

RELATING TO LABOR.

LAB, FIN

Status

Requires employers to provide a minimum amount of paid sick leave to employees to be used to care for themselves or a family member

who is ill or needs medical care.

HB 2200 Status RELATING TO PUBLIC SAFETY.

LAB, JUD

Allows an employer to seek a temporary restraining order and

injunction against further harassment of an employee or invitee who may be harassed at the employer's premises or worksite.

HB 2201 LAB, JUD Clarifies that Hawaii's anti-discrimination law does not prohibit or Status prevent an employer, employment agency, or labor organization from refusing to hire or refer or from discharging an individual for reasons unrelated to unlawful discriminatory practices. RELATING TO FAMILY LEAVE. LAB, FIN HB 2250 Adds routine medical care for a child as a qualifying reason for parents Status to use family leave under chapter 398. HB 1867 RELATING TO FAMILY AND MEDICAL LEAVE. LAB, FIN Status Establishes the Paid Family and Medical Leave Program. Creates fund. RELATING TO FAMILY LEAVE. LAB, FIN HB 2136 Establishes a family leave insurance program, which requires **Status** employees and employers to make contributions into an insurance fund to be used to provide employees with family leave insurance benefits in order to care for a designated person. Appropriates funds to implement the program. RELATING TO FAMILY LEAVE. HB 2598 LAB, FIN

Proposed HD1 Proposed HD1: Requires the Department of Labor and Industrial Relations to establish paid family leave for all workers by 1/1/2023.

Authorizes the department to adopt interim rules. Establishes the paid family leave implementation task force to assist the department and report to the Legislature. Establishes a paid family leave special fund.

Appropriates moneys.
