SENATE RESOLUTION

REQUESTING THE DEPARTMENT OF HEALTH TO CONVENE A TASK FORCE TO STUDY AND MAKE RECOMMENDATIONS ON THE FEASIBILITY OF REPURPOSING LEAHI HOSPITAL AND MALUHIA HOSPITAL AS CENTERS FOR COMMUNITY-BASED MENTAL HEALTH AND SUBSTANCE ABUSE TREATMENT SERVICES FOR NON-FORENSIC PATIENTS.

1 WHEREAS, there is a pressing need for expanded community-
2 based mental health and substance abuse treatment services in
3 Hawaii and the only State facility for such services is the
4 Hawaii State Hospital, which is at capacity and exclusively used
5 to treat forensic patients; and

6
7 WHEREAS, a significant contributing factor to high forensic
8 utilization is due to individuals ordered to the Hawaii State
9 Hospital for temporary hospitalization for lack of alternative
10 treatment options; and

11
12 WHEREAS, beds provided on contract by the private sector in
13 Hawaii and on the mainland cost over thirteen million dollars
14 per year; and

15
16 WHEREAS, the Legislature has appropriated funds for the
17 design and construction of a new secure forensic patient
18 facility to be completed but there is no additional provision
19 for beds and other services for patients who do not need the
20 restrictive environment at Hawaii State Hospital; and

21
22 WHEREAS, community capacity for mental health treatment is
23 inadequate at outpatient, intermediate, and inpatient levels;
24 and

26 WHEREAS, public buildings constructed for the provision of
27 health care, such as Leahi Hospital and Maluhia Hospital,
28 continue to serve as safety net facilities to meet existing and
29 emergent community needs; and

30
31 WHEREAS, Leahi Hospital and Maluhia Hospital have bed space
32 and facilities appropriate for providing memory care, mental
33 health, and substance abuse treatment services; and

2 WHEREAS, Leahi Hospital is adjacent to Kapiolani Community
3 College, which has a long history of health care training and
4 would be well-positioned to serve as a teaching hospital to
5 train behavioral health workers; now, therefore,

7 BE IT RESOLVED by the Senate of the Thirtieth Legislature
8 of the State of Hawaii, Regular Session of 2019, that the
9 Department of Health is requested to convene a task force to
10 study and make recommendations on the feasibility of Leahi
11 Hospital and Maluhia Hospital as centers for community-based
12 mental health and substance abuse treatment services for non-
13 forensic patients who do not need the restrictive care necessary
14 at the Hawaii State Hospital; and

16 BE IT FURTHER RESOLVED that the task force is requested to
17 consist of not more than nine individuals or their designees,
18 and to include:
19

- 20 (1) The Director of Health;
- 21
- 22 (2) Two members of the Senate appointed by the President
23 of the Senate;
- 24
- 25 (3) Two members of the House of Representatives appointed
26 by the Speaker of the House of Representatives;
- 27
- 28 (4) The Chief Executive Officer of the Hawaii Health
29 Systems Corporation, Oahu Region; and
- 30
- 31 (5) A representative from the mental health and substance
32 abuse provider community; and

34 BE IT FURTHER RESOLVED that the Director of Health or the
35 Director's designee shall serve as the chairperson of the task
36 force; and

38 BE IT FURTHER RESOLVED that an initial meeting be held no
39 later than June 1, 2019; and

41 BE IT FURTHER RESOLVED that the task force, with the
42 assistance of the Department of Health, is requested to submit a

1 report of its findings and recommendations, including any
 2 proposed legislation, to the Legislature no later than twenty
 3 days prior to the convening of the Regular Session of 2020; and
 4

5 BE IT FURTHER RESOLVED that the task force be dissolved on
 6 June 30, 2020; and

8 BE IT FURTHER RESOLVED that certified copies of this
 9 Resolution be transmitted to the Director of Health, Chief
 10 Justice of the Hawaii Supreme Court, Attorney General, Chief
 11 Executive Officer of the Hawaii Health Systems Corporation,
 12 Regional Chief Executive Officer of the Hawaii Health Systems
 13 Corporation Oahu Region, Senate President, and Speaker of the
 14 House of Representatives.
