SENATE CONCURRENT RESOLUTION

REQUESTING THE HAWAII STATE ENERGY OFFICE, DEPARTMENT OF
AGRICULTURE, AND DEPARTMENT OF LAND AND NATURAL RESOURCES
TO DEVELOP AND PRESENT A PLAN TO UTILIZE APPROPRIATE STATE
LAND FOR RENEWABLE ENERGY PROJECTS.

1 WHEREAS, section 269-92, Hawaii Revised Statutes,
2 establishes the goal that, by 2045, all electric energy
3 generated in the State shall be from renewable energy sources;
4 and

5
6 WHEREAS, in 2016, Governor David Ige pledged to double
7 local food production by 2030; and

8
9 WHEREAS, the Department of Agriculture and Department of
10 Land and Natural Resources each have large land portfolios,
11 including acres of land not used for their mission; and

12
13 WHEREAS, much of that land has the potential to house
14 renewable energy projects; and

15
16 WHEREAS, it is the responsibility of the Hawaii State
17 Energy Office to promote renewable energy generation; now,
18 therefore,

20 BE IT RESOLVED by the Senate of the Thirtieth Legislature
21 of the State of Hawaii, Regular Session of 2020, the House of
22 Representatives concurring, that the Hawaii State Energy Office,
23 Department of Agriculture, and Department of Land and Natural
24 Resources are requested to develop and present a plan to utilize
25 state land for renewable energy projects for the benefit of
26 achieving the one hundred percent renewable energy goal
27 established by section 269-92, Hawaii Revised Statutes; and

29 BE IT FURTHER RESOLVED that the plan include an estimate of
30 the land available for renewable energy projects, potential

1 renewable energy capabilities by resource and wattage, and any
2 required land entitlements; and

4 BE IT FURTHER RESOLVED that the plan also recommend
5 policies to efficiently and effectively accomplish renewable
6 energy goals; and

7

8 BE IT FURTHER RESOLVED that the plan be cognizant of the
9 potential impacts to neighboring communities; and

10

11 BE IT FURTHER RESOLVED that the Hawaii State Energy Office,
12 Department of Agriculture, and Department of Land and Natural
13 Resources are requested to memorialize the plan in writing and
14 submit it to the Legislature no later than twenty days prior to
15 the Regular Session of 2021; and

17 BE IT FURTHER RESOLVED that certified copies of this
18 Concurrent Resolution be transmitted to Chairperson of the Board
19 of Agriculture, Chairperson of the Board of Land and Natural
20 Resources, and Chief Energy Officer.
