BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

 8 health systems corporation, and belong to the same compensation
 9 plans as those officers and employees within bargaining unit
 10 (10):

 19 in this Act for any officer or employee whose compensation is
 20 paid, in whole or in part, from federal, special, or other funds



1 shall be paid wholly or proportionately, as the case may be,
2 from the respective funds.

3 SECTION 14. The fiscal year 2021-2022 appropriations or
4 authorizations under this Act shall not lapse until the end of
5 fiscal biennium 2021-2023; provided that funds appropriated or
6 authorized by this Act that are not expended or encumbered by
7 June 30, 2023, shall lapse as of that date.

8 SECTION 15. This Act shall take effect on July 1, 2050.
