
A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that transparency and
2 accountability are critical to ensuring public agencies are
3 effective and efficient and successfully provide services in the
4 public interest. The legislature further finds that departments
5 of transportation throughout the country typically spend more on
6 public infrastructure than any other state agency. As a result,
7 most departments of transportation throughout the country have
8 mechanisms such as oversight commissions and requirements for
9 robust reporting to ensure public transparency and
10 accountability for the billions of dollars they spend. This
11 enables elected leaders and the public to evaluate and track
12 transportation projects and ensure they successfully achieve
13 state goals as quickly and efficiently as possible.

14 The legislature further finds that no commission currently
15 exists in Hawaii to provide meaningful transparency and
16 accountability regarding transportation efforts. There is also
17 no public means of evaluating proposed or ongoing projects to



1 determine if or how much they will help change outcomes. There
2 are few readily available metrics to track whether overall
3 progress is being made toward many state transportation goals.
4 In some cases, planned projects are projected to reverse
5 progress toward some state goals.

6 Hawaii has among the worst traffic fatality rates in the
7 country, including the worst senior citizen pedestrian fatality
8 rate. Hawaii also has among the worst traffic congestion in the
9 country, and among the highest cost of transportation, which
10 greatly increases the cost of living for residents.
11 Unfortunately, Hawaii has held these distinctions for some time
12 with little change.

13 The purpose of this Act is to help improve transportation
14 outcomes by enabling basic transparency and accountability for
15 transportation efforts by:

16 (1) Amending the duties and membership of the state
17 highway safety council and renaming the council as the
18 transportation safety and modernization council to
19 help ensure that the department of transportation
20 achieves state goals and outcomes; and



1 (2) Requiring improved reporting to provide better
2 transparency to elected leaders and the public.

3 SECTION 2. Section 286-5, Hawaii Revised Statutes, is
4 amended to read as follows:

5 "~~§286-5~~ [State highway] Transportation safety and
6 modernization council. (a) There is established the [~~Hawaii~~
7 ~~highway]~~ transportation safety and modernization council. The
8 director of transportation shall serve as its chairperson. The
9 following or their designated representatives shall be members
10 of the council: the chief justice, the attorney general, the
11 director of health, the superintendent of education, the
12 [~~president]~~ chair of the University of Hawaii[~~7~~] at Manoa
13 department of urban and regional planning, the co-chairs of the
14 Hawaii climate change mitigation and adaptation commission, the
15 director of the office of planning and sustainable development,
16 the chief energy officer of the Hawaii state energy office, the
17 chair of the senate standing committee having subject matter
18 jurisdiction over transportation, the member of the senate
19 having jurisdiction over capital improvement projects, the chair
20 of the house of representatives standing committee having
21 subject matter jurisdiction over transportation, the member of



1 the house of representatives having jurisdiction over capital
2 improvement projects, the chairperson of each of the county
3 highway safety councils established under section 286-6, and not
4 more than [~~twenty~~] ten other persons who shall be appointed by
5 the governor for a three-year term as follows:

6 (1) One member from an organization representing senior
7 citizens;

8 (2) One member from an organization representing
9 bicyclists;

10 (3) One member from an organization having a focus on
11 urban planning;

12 (4) One member from an organization having a focus on
13 transportation, planning, and improvement;

14 (5) One member from an organization that serves low-income
15 communities;

16 (6) One member from an organization representing labor and
17 construction;

18 (7) One member from an organization representing trucking
19 and cargo carriers; and



1 (8) Up to three members on the basis of [~~their~~] each
 2 member's interest in [~~highway~~] transportation
 3 safety[~~-~~] and modernization.

4 The [~~state highway~~] transportation safety and modernization
 5 council shall [~~advise~~]:

6 (1) Provide direction to help the department of
 7 transportation achieve ground transportation, safety,
 8 modernization, and other state goals;

9 (2) Establish metrics and benchmarks, and provide regular
 10 reporting, to help the department of transportation
 11 achieve state goals; and

12 (3) Advise the governor, legislature, and public on
 13 matters relating to the programs [~~and~~], activities,
 14 and plans of the State in the field of [~~highway~~]
 15 transportation safety[~~-~~] and modernization.

16 (b) The department of transportation shall provide
 17 information on ground transportation plans, projects, and any
 18 other relevant information to the transportation safety and
 19 modernization council.



1 (c) The members of the council shall serve without pay but
2 shall be entitled to reimbursement for necessary expenses while
3 attending meetings and while in discharge of their duties."

4 SECTION 3. Statutory material to be repealed is bracketed
5 and stricken. New statutory material is underscored.

6 SECTION 4. This Act shall take effect on July 1, 2022.
