Dear Senate President Kouchi and Speaker Saiki:

An arbitration award has been issued concerning the Hawai'i Firefighters Association (HFFA) collective bargaining (CB) for Unit 11 (Firefighters). The award was issued on April 25, 2022. In accordance with Section 89-11, cost items must be submitted to the Legislature for appropriation. The following summary of the included and excluded requirements of the settlement for the current fiscal biennium is being transmitted to the Legislature for authorization:

A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:
