### A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION REVIEWS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that section 6E-8, Hawaii
- 2 Revised Statutes, plays an important role in the protection and
- 3 management of the State's historic properties and burial sites.
- 4 Section 6E-8(b) requires the department of Hawaiian home lands,
- 5 prior to any proposed project relating to lands under its
- 6 jurisdiction, to consult with the department of land and natural
- 7 resources regarding the effect of the project upon historic
- 8 property or a burial site. The purpose of this Act is to allow
- 9 the department of Hawaiian home lands to directly assume review
- 10 of proposed projects relating to lands under its jurisdiction,
- 11 rather than consulting the department of land and natural
- 12 resources for the effect of those projects upon historic
- 13 properties or burial sites.
- 14 SECTION 2. Section 6E-8, Hawaii Revised Statutes, is
- 15 amended by amending subsection (b) to read as follows:
- 16 "(b) [The] Notwithstanding subsection (a) to the contrary,
- 17 the department of Hawaiian home lands[ prior to] may assume

Allows DHHL to assume historic preservation review of the effect of any proposed state project for lands under its jurisdiction under certain conditions and subject to certain exceptions for state projects affecting properties listed or nominated for inclusion in the Hawaii register of historic places or the national register of historic places or located in a designated historic district. Effective 7/1/2050. Repealed on 6/30/2027. (HD2)
