
A BILL FOR AN ACT

RELATING TO NATIVE HAWAIIAN AFFAIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The departments and agencies listed in section
2 2 of this Act shall provide grants to federal tax-exempt
3 nonprofit organizations that have previously received government
4 assistance to support their organizational mission and also
5 possess at least twenty years of providing assistance and
6 support to Native Hawaiian communities.

7 The grants shall be tailored toward improving Native
8 Hawaiian communities and culture through various assistance
9 programs, including but not limited to programs that offer food
10 sustainability; development of renewable infrastructure; Native
11 Hawaiian historic preservation; development of a mill to process
12 ulu and taro; business training, entrepreneurship, and
13 mentoring; farming; education; cultural training; and
14 environmental management.

15 The grants shall be awarded in conformance with the
16 standards in section 42F-103, Hawaii Revised Statutes.



1 SECTION 2. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$15,700,000 or so
3 much thereof as may be necessary for fiscal year 2022-2023 to be
4 allocated to the following departments and agencies and used for
5 grants pursuant to section 1 of this Act for the following
6 programs:

7 (1) The department of agriculture:

8 (A) The sum of \$690,000; provided that the sum is
9 used to expand infrastructure, increase food
10 production, and develop the economic stability of
11 loko i'a statewide through hatchery and solar
12 power programs;

13 (B) The sum of \$100,000; provided that the sum is
14 used for a statewide kalo farming needs
15 assessment; and

16 (C) The sum of \$10,000,000; provided that the sum is
17 used for the development of a mill to process ulu
18 and taro;

19 (2) The department of business, economic development, and
20 tourism:



1 (A) The sum of \$500,000; provided that the sum is
2 used for the Pop-up Makeke virtual marketplace
3 that supports local artisans and businesses to
4 adapt to e-commerce;

5 (B) The sum of \$250,000; provided that the sum is
6 used for a West Oahu Innovation Center that is a
7 physical co-working space and an entrepreneur and
8 resource center that provides workshops,
9 counseling, loan assistance, and broadband
10 access;

11 (C) The sum of \$200,000; provided that the sum is
12 used for culture training programs with military
13 personnel, small businesses, and nonprofit
14 organization; and

15 (D) The sum of \$2,500,000; provided that the sum is
16 used for community-based tourism management,
17 including tourism impacts on the natural and
18 cultural resources of local communities;

19 (3) The department of labor and industrial relations the
20 sum of \$920,000; provided that the sum is used for
21 staffing, cohorts, and software needs of the Hawaiian



1 Trades Academy and Kuhana Business Development Program
2 that prepares individuals and businesses for economic
3 success and self-sufficiency; and

4 (4) The department of land and natural resources:

5 (A) The sum of \$330,000; provided that the sum is
6 used for the repatriation and reburials of Native
7 Hawaiians nationally and internationally; and

8 (B) The sum of \$210,000; provided that the sum is
9 used for Iolani Palace operations, maintenance,
10 and repairs.

11 The sums appropriated shall be expended by the department
12 or agency listed above for the purposes of this Act.

13 SECTION 3. This Act shall take effect on July 1, 2022.
