SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF HEALTH TO CONVENE A MEDICINAL
PSILOCYBIN AND PSILOCIN WORKING GROUP TO EXAMINE THE
MEDICINAL AND THERAPEUTIC EFFECTS OF PSILOCYBIN AND
PSILOCIN AND DEVELOP A LONG-TERM STRATEGIC PLAN TO ENSURE
THE AVAILABILITY OF MEDICINAL PSILOCYBIN AND PSILOCIN OR
PSILOCYBIN-BASED AND PSILOCIN-BASED PRODUCTS THAT ARE SAFE,
ACCESSIBLE, AND AFFORDABLE FOR ELIGIBLE ADULT PATIENTS.

1 WHEREAS, mental health conditions are treated in various
2 ways depending on the condition and can include medication,
3 therapy, and psychosocial services; and
4

5 WHEREAS, these treatments, while effective for certain
6 conditions and patients, do not treat all mental health
7 conditions; and
8

9 WHEREAS, psilocybin and psilocin occur naturally in certain
10 species of mushrooms; and
11

12 WHEREAS, psilocybin and psilocin are natural chemicals that
13 can activate serotonin receptors in the brain; and
14

15 WHEREAS, studies conducted by nationally and
16 internationally recognized medical institutions indicate that
17 psilocybin and psilocin have shown efficacy, tolerability, and
18 safety in the treatment of a variety of mental health
19 conditions, including addiction, depression, anxiety disorders,
20 and end-of-life psychological distress; and

22 WHEREAS, the United States Food and Drug Administration has
23 determined that preliminary clinical evidence indicates that
24 psilocybin and psilocin may demonstrate substantial improvement
25 over available therapies for major depressive disorder and
26 severe treatment-resistant depression and has granted a
27 breakthrough therapy designation for a treatment that uses



1 psilocybin and psilocin as a therapy for these mental health
2 conditions; and

3
4 WHEREAS, Hawaii has a shortage of mental health
5 professionals and should actively consider novel, innovative,
6 and safe solutions to treat its citizens; now, therefore,

8 BE IT RESOLVED by the Senate of the Thirty-second
9 Legislature of the State of Hawaii, Regular Session of 2023, the
10 House of Representatives concurring, that the Department of
11 Health is requested to convene a Medicinal Psilocybin and
12 Psilocin Working Group, to be placed in the Department of Health
13 for administrative purposes; and

15 BE IT FURTHER RESOLVED that the Medicinal Psilocybin and
16 Psilocin Working Group is requested to examine:

18 (1) Federal, state, and local laws, regulations,
19 administrative rules, and procedures regarding the
20 medicinal use of psilocybin and psilocin;
21
22 (2) Available medical, psychological, and scientific
23 studies, research, and other information relating to
24 the safety and efficacy of psilocybin and psilocin in
25 treating mental health conditions; and
26
27 (3) Requirements, specifications, and guidelines for a
28 medical professional to prescribe and provide
29 psilocybin and psilocin to patients; and
30

31 BE IT FURTHER RESOLVED that, if feasible, the Medicinal
32 Psilocybin and Psilocin Working Group is requested to develop a
33 long-term strategic plan to ensure the availability of medicinal
34 psilocybin and psilocin or psilocybin-based and psilocin-based
35 products that are safe, accessible, and affordable for adults
36 twenty-one years of age or older; and

38 BE IT FURTHER RESOLVED that the following individuals, or
39 their respective designees, are requested to serve as members of
40 the Medicinal Psilocybin and Psilocin Working Group:

- 1 (1) The Director of Health, who is requested to serve as
2 chair;

- 4 (2) The Attorney General;
- 5
- 6 (3) Faculty members from the University of Hawaii System
7 with relevant scientific expertise;
- 8
- 9 (4) The chairs of the Senate and House of Representatives
10 standing committees whose subject matter purview is
11 primarily responsible for reviewing legislation
12 relating to health and the Judiciary;
- 13
- 14 (5) A clinical practitioner licensed to prescribe
15 psychotropic medication in the State of Hawaii;
- 16
- 17 (6) A representative of the Drug Policy Forum of Hawaii,
18 to be invited by the chair of the working group;
- 19
- 20 (7) A representative of the Clarity Project, to be invited
21 by the chair of the working group;
- 22
- 23 (8) A representative of the Hawaii Psychiatric Medical
24 Association, to be invited by the chair of the working
25 group; and
- 26
- 27 (9) A representative of the public with
28 psychedelics-related industry experience, to be
29 invited by the chair of the working group; and

31 BE IT FURTHER RESOLVED that the chair of the Medicinal
32 Psilocybin and Psilocin Working Group may invite other
33 interested parties with relevant experience to join the working
34 group, provided that the working group does not exceed fifteen
35 members; and
36

37 BE IT FURTHER RESOLVED that the Medicinal Psilocybin and
38 Psilocin Working Group is requested to submit a preliminary
39 report of its findings and recommendations to the Legislature no
40 later than twenty days prior to the convening of the Regular
41 Session of 2024, and a final report of its findings and
42 recommendations, including any proposed legislation, to the

1 Legislature no later than twenty days prior to the convening of
2 the Regular Session of 2025; and

3

4 BE IT FURTHER RESOLVED that the Medicinal Psilocybin and
5 Psilocin Working Group be dissolved on July 1, 2025; and

6

7 BE IT FURTHER RESOLVED that certified copies of this
8 Concurrent Resolution be transmitted to the Director of Health,
9 who in turn shall notify the non-governmental organizations
10 represented in the working group; Attorney General; and
11 President of the University of Hawaii.
