A BILL FOR AN ACT

RELATING TO SCHOOL IMPACT FEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 302A-1603, Hawaii Revised Statutes, is
2 amended by amending subsection (b) to read as follows:
- 3 "(b) The following shall be exempt from this section:
- 4 (1) Any form of housing permanently excluding school-aged
5 children, with the necessary covenants or declarations
6 of restrictions recorded on the property;
- 7 (2) Any form of housing that is or will be paying the
8 transient accommodations tax under chapter 237D;
- 9 (3) All nonresidential development;
- 10 (4) Any development with an executed education
11 contribution agreement or other like document with the
12 authority or the department for the contribution of
13 school sites or payment of fees for school land or
14 school construction;
- 15 (5) Any form of housing developed by the department of
16 Hawaiian home lands for use by beneficiaries of the
17 Hawaiian Homes Commission Act, 1920, as amended; ~~and~~



- 1 (6) Any form of development by the Hawaii community
2 development authority pursuant to part XII of chapter
3 206E[-];
- 4 (7) Any form of housing that provides eighty per cent of
5 units as affordable for fifteen years to qualified
6 individuals earning up to one hundred per cent area
7 median income with rents at or below rental limits set
8 by the Department of Housing and Urban Development;
- 9 (8) Any development constructed under the affordable
10 rental housing development program or for-sale
11 developments administered by the Hawaii housing and
12 finance development corporation pursuant to chapter
13 201H;
- 14 (9) Any development or project that is exempt from general
15 excise taxes pursuant to section 201H-36;
- 16 (10) Any development receiving federal, state, or county
17 funds such as from the rental housing revolving fund
18 or low-income housing tax credits;
- 19 (11) Any development constructed on federal, state, or
20 county-owned land;



1 (12) Any form of housing that is available only for Hawaii
2 residents who are owner-occupants and who own no other
3 real property; and


4 (13) Any development that utilizes Department of Housing
5 and Urban Development funding."

6 SECTION 2. Statutory material to be repealed is bracketed
7 and stricken. New statutory material is underscored.

8 SECTION 3. This Act shall take effect upon its approval;
9 provided that the amendments made to section 302A-1603(b),
10 Hawaii Revised Statutes, by section 1 of this Act shall not be
11 repealed when that section is reenacted on July 1, 2024,
12 pursuant to section 6 of Act 197, Session Laws of Hawaii 2021.
