A BILL FOR AN ACT

RELATING TO GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to require public 2 access to travel reports submitted by state employees, officers, 3 and other representatives of the State who travel on official 4 state business. 5 SECTION 2. Chapter 40, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to 6 7 read as follows: 8 "§40- Travel reports; official state business; public 9 access. (a) Any travel report submitted by a state employee, 10 officer, or other representative of any state department or 11 agency, including the judiciary and university of Hawaii, in 12 connection with out-of-state or intra-state travel for purposes 13 of official state business, shall be made available for public 14 review on the comptroller's website in a searchable format; provided that: 15 16 Any personally identifiable information shall be (1) 17 redacted from the published report;

New statutory material is underscored. 13 SECTION 6. This Act shall take effect on July 1, 2026; 14 provided that section 4 shall take effect on July 1, 2024.

Report Title:

Department of Accounting and General Services; Comptroller; Travel Reports; Public Access; General Fund Expenditure Ceiling Exceeded; Appropriation

Description:

Generally requires that travel reports submitted by state employees, officers, or other representatives of state departments or agencies, in connection with out-of-state or intra-state travel for purposes of official state business, be made available for public review on the Comptroller's website. Requires any personally identifiable information to be redacted from each published report. Provides certain exceptions relating to law enforcement, off-island travel, confidentiality, and board and commission meetings. Appropriates moneys. Declares that the general fund expenditure ceiling is exceeded. (SD2)
