A BILL FOR AN ACT

RELATING TO MISSING PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the State must
 protect vulnerable kupuna and persons with cognitive impairments
 or developmental disabilities who are missing. More than half
 of states nationwide have established silver alert programs
 modeled after the amber alert program.

Broadcasters use systems like the emergency alert system,
formerly known as the emergency broadcast system, or wireless
emergency alert, to communicate emergency alerts and warning
messages to the public.

10 There are many emergency situations where the use of these 11 broadcast systems could save lives by helping identify missing 12 individuals with cognitive impairments, developmental 13 disabilities, or the elderly. However, there is no statutory 14 process which requires its use.

15 The purpose of this Act is to establish a silver alert 16 program within the department of law enforcement to alert the 17 public of missing persons for whom there is a credible threat to

2	alert shall provide protection of the privacy, dignity, and
3	independence of the missing person by including standards aimed
4	at preventing the inadvertent or unnecessary broadcasting or
5	dissemination of sensitive health and diagnostic information.
6	SECTION 2. Chapter 353C, Hawaii Revised Statutes, is
7	amended to read as follows:
8	" <u>§353C-</u> Silver alert program; missing vulnerable
9	persons. (a) The department of law enforcement shall develop
10	and implement a silver alert program to rapidly disseminate
11	information about a person subject to the alert.
12	(b) If a person is reported missing to a law enforcement

19	investigating law enforcement agency.

1	(c) Radio, television, cable, and satellite systems are
2	encouraged to, but not required to, cooperate with disseminating
3	the information contained in a silver alert.
4	(d) Upon activation of a silver alert, if the department
5	of law enforcement believes the criteria of subsection (g)(4) is
6	met, the department shall assist the investigating law
7	enforcement agency by issuing a be-on-the-lookout alert, issuing
8	an electronic flyer, or activating a changeable message sign, as
9	permissible.
10	(e) The department of law enforcement may use, as
11	permitted, the Wireless Emergency Alerts.
12	(f) The department of law enforcement may use, as
13	permitted, a changeable message sign, if the following
14	conditions are met:
15	(1) The investigating law enforcement agency determines
16	that a vehicle may be involved in the missing person
17	incident; and
18	(2) Specific vehicle identification is available for
19	public dissemination.

3	"Developmentally disabled" means affected by a
4	developmental disability, as defined in section 11-88.1-2 of the
5	Hawaii Administrative Rules.
6	"Silver alert" means a notification system, activated
7	pursuant to subsections (b) through (e), designed to issue and
8	coordinate alerts with respect to a person who is sixty-five
9	years of age or older, cognitively impaired, or developmentally
10	disabled, and meets requirements of subsection (g)."
11	SECTION 3. There is appropriated out of the general

2	appropriation contained in this Act will cause the general fund
