### A BILL FOR AN ACT

RELATING TO IMMIGRATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is an 2 unfulfilled need in the State for broad-based, dedicated 3 services for recent immigrants to assist them with issues 4 relating to language access; legal issues relating to their 5 status as immigrants; acculturation with respect to legal 6 responsibilities, employment responsibilities, family matters, 7 and other acculturation issues; employment searches; support for 8 their children's education; access to health care; inclusion and 9 civic engagement; and a myriad of other challenges and 10 opportunities.

11 The legislature finds that Hawaii has a long history of 12 welcoming immigrants. Immigrants and their children have made, 13 and continue to make, significant contributions to the State, 14 including the State's economy, workforce, and community.

15 The legislature further finds that immigrants comprise two 16 hundred seventy thousand persons, or eighteen per cent, of 17 Hawaii's population, including 145,000 persons who are

naturalized citizens. Immigrants come to Hawaii from many
 countries; almost half of all immigrants in the State come from
 the Philippines. Immigrants make up forty per cent of
 agricultural workers, thirty-three per cent of tourism and
 hospitality workers, and twenty-three per cent of health care
 workers in the State.

7 The legislature further finds that other states provide 8 immigrant and refugee services through state-funded offices with 9 dedicated staff and program funds for immigrant integration. 10 These offices also coordinate with other government and 11 community agencies and apply for federal resources. This type 12 of office exists in Maryland, Massachusetts, Nevada, and New 13 York. In California, the department of social services has an 14 immigrant services bureau that ensures the effective development 15 and implementation of programs to support legal services, 16 outreach, community education, and other integration efforts. 17 Many cities across the nation, including Los Angeles, San 18 Francisco, and Seattle have also established comprehensive, 19 government-funded offices for immigrant and refugee affairs. 20 Many of these offices provide funds for English language 21 training, translation and interpretation, workforce development,



1 and legal services related to immigration status,

naturalization, and accessing government services. In Hawaii,
the counties of Maui and Hawaii have offices offering limited
services, but there are none in the county of Kauai or the city
and county of Honolulu.

6 Pursuant to House Concurrent Resolution No. 169, Regular 7 Session of 2021, the legislature convened a working group to 8 "improve access to government services for immigrants and 9 increase immigrant opportunities to make civic and economic 10 contributions to the community." As part of the working group, 11 community groups identified the office of community services as 12 the best state agency to service immigrants and suggested that 13 the office be given dedicated staff to address immigrant and 14 refugee matters. In response, Act 256, Session Laws of Hawaii 15 2022, provided \$1,000,000 to reinstate immigrant resource 16 centers and to support nonprofit immigrant service agencies. 17 The legislature notes that in 1985, the office of community 18 services was established as an attached agency to the department 19 of labor and industrial relations. The legislative mandate of 20 the office of community services is to serve low-income 21 individuals, immigrants, and refugees.



1 The legislature believes that further action is needed to support programs for Hawaii's immigrants and refugees, to 2 3 support immigrant services, and to ensure that new immigrants 4 have equal access to government services. 5 Accordingly, the purpose of this Act is to provide for additional dedicated staff and additional program funds to allow 6 7 the office of community services to meet its full legislative 8 mandate, by establishing an immigration services and access unit 9 within the office of community services. 10 SECTION 2. Chapter 371K, Hawaii Revised Statutes, is 11 amended by adding a new section to be appropriately designated 12 and to read as follows: 13 "§371K- Immigration services and access unit. The 14 office of community services shall establish within the office a 15 unit to provide for immigration services and access through 16 funding staff and program activities identified for immigration 17 services and access purposes. The purpose of the immigration 18 services and access unit shall be to promote immigrant economic 19 self-sufficiency, community inclusion, and integration. The 20 immigration services and access unit shall provide statewide services, coordinate with relevant government and nonprofit 21

| 11 | and this Act will cause the state general fund expenditure       |
| 12 | ceiling for fiscal year 2024-2025 to be exceeded by              |
| 13 | \$ or per cent. This current declaration takes                   |
| 14 | into account general fund appropriations authorized for fiscal   |
| 15 | year 2024-2025 in Act 164, Regular Session of 2023, and this Act |
| 16 | only. The reasons for exceeding the general fund expenditure     |
| 17 | ceiling are that:  |

1 SECTION 4. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2024-2025 to 3 4 full-time equivalent ( FTE) positions and establish 5 fund the immigrant services and access unit within the office of 6 community services. 7 The sum appropriated shall be expended by the department of labor and industrial relations for the purposes of this Act. 8 9 SECTION 5. New statutory material is underscored. 10 SECTION 6. This Act shall take effect on July 1, 2024.
