## A BILL FOR AN ACT

RELATING TO THE STRATEGIC PLAN TO INCREASE FOOD PRODUCTION AND FOOD SECURITY.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that the department of agriculture's 2020 report entitled, "Report on the Strategic 2 Plan to Double Local Food Production and Exports by 2030", 3 prepared in accordance with Act 151, Session Laws of Hawaii 4 2019, provides suggested actions to achieve substantial 5 individual or cumulative increases in local food production and 6 export. This strategic plan must be updated with supplemental 7 benchmarks to measure progress toward goals quantitatively and 8 qualitatively and to address the changing landscape of the 9 10 agriculture industry, including the changes sustained by the 11 global and local food systems due to the COVID-19 pandemic.

12 The legislature further finds that it is an urgent 13 necessity for Hawaii to be more food secure. The COVID-19 14 pandemic showed the fragility of the State's food system as food 15 manufacturing plants throughout the world shut down, shipping 16 lessened, and food shortages were experienced by retailers and 17 consumers. Unprecedented stresses were observed on the

production, processing, transportation, and consumption of food 1 2 and food-related items.

The purpose of this Act is to require the department of 3 agriculture to update and supplement the strategic plan to 4 increase Hawaii's food production and food security. 5

6 SECTION 2. (a) The department of agriculture, in cooperation with the office of the governor, shall update and 7 supplement the strategic plan to: 8

Set goals to increase the State's food production; 9 (1)10 (2) Further establish food export markets to increase Hawaii's food security; and 11

Identify benchmarks for increased food production in 12 (3) the State and increased exports of food crops and 13 value-added agricultural products from the State.

(b) The strategic plan shall include a phased framework, 15 actions that minimize financial risk to Hawaii producers, 16 baseline data, and specific, measurable, achievable, relevant, 17

18 time-bound goals.

2	revenues of the State of Hawaii the sum of \$600,000 or so much

6	agriculture for the purposes of this Act.
7	SECTION 5. This Act, upon its approval, shall take effect
8	on July 1, 2024.
