### A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF EDUCATION FOR CHARTER SCHOOLS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act is recommended by the governor for
 immediate passage in accordance with section 9 of article VII of
 the Constitution of the State of Hawaii.

13 authorized for fiscal year 2023-2024 in this Act only. The 14 reasons for exceeding the general fund expenditure ceiling are

# (2) The appropriations made in this Act meet the needs addressed by this Act.

SECTION 3. The department of education is required to 3 4 provide proportional funding to charter schools based on their student enrollment. Even though the overall enrollment for the 5 6 department of education has gone up for the 2023 to 2024 school 7 year, the growth rate for public charter schools has grown even 8 faster at four per cent higher than projected. One factor that 9 explains the sudden increased public charter school enrollment 10 is the growing need for temporary school options in Lahaina as a 11 result of the destruction incurred by the devastating wildfires. 12 As a result of the increased charter school enrollment, the 13 amount of funding for charter schools is less than what is 14 required.

15 The purpose of this Act is to make an emergency
16 appropriation to provide moneys for the department of education
17 to cover its funding requirements for charter schools.

18 SECTION 4. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$6,600,000 or so much 20 thereof as may be necessary for fiscal year 2023-2024 for the 21 department of education to provide funding for charter schools.

#### JUSTIFICATION SHEET SB. NO. 3092

DEPARTMENT: Education

TITLE: MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF EDUCATION FOR CHARTER SCHOOLS.

PURPOSE: To provide the Department with funding for charter schools.

MEANS: Make an emergency appropriation of general funds to the Department.

JUSTIFICATION: The Department is required to provide proportional funding to charter schools based on their student enrollment. Even though overall Department student enrollment is up for the 2023 to 2024 school year, the growth rate for public charter schools was even higher at four percent higher than projected.

> The amount of funding provided by the Legislature in the 2023 legislative session for charter schools was less than required. For example, the Hawaii Tech Academy's increase in enrollment in the beginning of 2023-2024 school year was the stopgap measure to temporarily provide relief to students displaced by the wildfires in Lahaina.

Impact on the public: The funding in this bill will provide needed financial resources for charter schools to be able to provide services to the students they serve. Providing equally proportionate funding to charter schools ensures that each school has adequate resources to provide for student success.

Impact on the department and other agencies: The Department is responsible for providing a proportional share of funding to charter schools based upon their student enrollment numbers. Without adequate funding by the Legislature, the Department does not have Page 2

the funds to provide the required funds to the charter schools.
