
SENATE RESOLUTION

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO
CONVENE A WORKING GROUP TO MAKE RECOMMENDATIONS ON
SOLUTIONS TO REDUCE WILDFIRE RISK AND THE FEASIBILITY OF
ESTABLISHING A VEGETATION MANAGEMENT PROGRAM AS IT RELATES
TO LANDOWNERS AND PUBLIC UTILITIES.

1 WHEREAS, on August 8, 2023, catastrophic wildfires swept
2 through various communities on Maui; and

3
4 WHEREAS, the wildfires impacted human life and the
5 community, housing, education, economy, and health of Maui
6 residents; and

7
8 WHEREAS, the presence of grasses, trees, and other
9 vegetation adjacent to or under electric utility lines poses a
10 significant risk to fire safety; and

11
12 WHEREAS, the House of Representatives, in response to the
13 August 2023 Maui wildfires, established six interim working
14 groups charged with evaluating specific topics related to the
15 wildfire and making recommendations for specific legislative
16 action; and

17
18 WHEREAS, the Wildfire Prevention Working Group, one of the
19 six aforementioned working groups, found that people are the
20 primary drivers of wildfires in Hawaii, as ninety-nine percent
21 of wildfires are caused by human ignitions; and

22
23 WHEREAS, the Wildfire Prevention Working Group also found
24 that guinea grass, fountain grass, molasses grass, and
25 buffelgrass can form continuous fuel beds, ignite easily, attain
26 extremely high fine fuel loads, and are capable of growing back
27 more vigorously in the post-fire environment than the majority
28 of native vegetation; and

30 WHEREAS, utility companies in the State have miles of
31 utility lines installed throughout the State on government and



1 private land including within the public rights of way and
2 mountainous areas of the State; and

3
4 WHEREAS, a significant portion of the aforementioned public
5 and private lands are covered in unmanaged grasses, trees, and
6 other vegetation that may pose a wildfire risk; now, therefore,

8 BE IT RESOLVED by the Senate of the Thirty-second
9 Legislature of the State of Hawaii, Regular Session of 2024,
10 that the Department of Land and Natural Resources is requested
11 to convene a working group to make recommendations on solutions
12 to reduce wildfire risk and the feasibility of establishing a
13 vegetation management program as it relates to landowners and
14 public utilities; and

15
16 BE IT FURTHER RESOLVED that the working group is requested
17 to study the need for policy, regulation, and guidance
18 pertaining to the management of and responsibility for
19 vegetation on public and private lands for wildfire mitigation
20 purposes; and

21
22 BE IT FURTHER RESOLVED that the working group is requested
23 to study, evaluate, and make recommendations regarding
24 regulations that define property owner obligations to perform
25 vegetation management on public and private property for
26 wildfire mitigation purposes; and

28 BE IT FURTHER RESOLVED that the working group is requested
29 to consist of the following members:

- 31 (1) Chairperson of the Board of Land and Natural Resources
32 or the Chairperson's designee who is requested to
33 serve as the chairperson of the working group;

36 the President of the Senate;

1 (17) A landowner that owns over one thousand acres of land,
2 to be invited by the chairperson of the working group;

5 BE IT FURTHER RESOLVED that the working group is requested
6 to submit a report of its findings and recommendations,
7 including any proposed legislation, to the Legislature no later
8 than twenty days prior to the convening of the Regular Session
9 of 2025; and

11 BE IT FURTHER RESOLVED that the working group is requested
12 to dissolve on June 30, 2025; and

14 BE IT FURTHER RESOLVED that certified copies of this
15 Resolution be transmitted to the President of the Senate;
16 Speaker of the House of Representatives; Chairperson of the
17 Board of Land and Natural Resources; Director of Transportation;
18 Chair of the Public Utilities Commission; Executive Director of
19 the Division of Consumer Advocacy of the Department of Commerce
20 and Consumer Affairs; Mayors of the City and County of Honolulu,
21 County of Maui, County of Hawaii, and County of Kauai; Co-Chairs
22 of the Hawaii Invasive Species Council; President of the Land
23 Use Research Foundation; President and Chief Executive Officer
24 of Hawaiian Electric; President and Chief Executive Officer of
25 Kauai Island Utility Cooperative; President of Maui Electric
26 Company, Limited; and President of Hawaii Electric Light
27 Company, Inc.
